**NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

**SWEEPSTAKES ENTRY PERIOD:** The **Sleep Number Advisory Panel Survey Sweepstakes** begins at 12:00:01 AM Eastern Time ("ET") on Friday, February 1, 2018 and ends at 11:59:59 PM ET on Tuesday, April 30, 2019 (the "Sweepstakes Period").

**ELIGIBILITY:** The Sleep Number Advisory Panel Survey Sweepstakes (the "Sweepstakes") is only open to legal residents of the 50 United States of America and the District of Columbia ("DC"), excluding Alaska, Hawaii, and Rhode Island, who are the age of majority or older, at time of entry. Void in Alaska, Hawaii, Rhode Island, outside the U.S. and wherever else prohibited by law. Employees of Sleep Number Corporation (the "Sponsor") and its parents, members, affiliates, subsidiaries and agencies, and their immediate family members (spouse, parents, children and siblings, and their respective spouses) and persons living in the household of each are not eligible to participate. **ENTRY:** There are two (2) ways to enter.

Contact information on file at Sponsor will be used to contact winners. It is the participant's responsibility to make sure that this information is kept current. Proof of entry does not constitute proof of submission. Online entrants are subject to all notices posted online including but not limited to the Sponsor's Privacy Policy.
